





Combating trafficking

in persons and the exploitation of migrants is a priority for IOM which believes that all migration should be safe. Sadly, too many people are deceived by criminal groups into travelling abroad, only to be exploited and abused on commercial farms, construction sites, or as domestic workers in private homes. Still others are exploited in the sex trade.

Since 1992, the Organization has assisted tens of thousands of trafficked persons and exploited migrants with safe accommodation, medical, psychosocial and legal support. It has provided migrants with options to return home, develop new skills, or start a small business. But promoting safe migration extends beyond these forms of direct assistance. IOM works to raise public awareness and encourage behavioural change among consumers of the goods and services produced and provided by trafficked persons and exploited migrants. Equally important are the Organization's efforts to equip aspirant migrants with essential information about employment and educational opportunities available abroad before they leave home, the requirements to take advantage of these, and whom to contact if they experience exploitation or abuse.

Introduction

The global scale of trafficking is difficult to quantify but recent trends show an increase in the instances of human trafficking for forced labour. Organized criminal groups are earning billions of dollars in profits from trafficking and exploiting people, many of whom suffer severe violations to their human rights.

Common abuses experienced by trafficked persons include rape, torture, debt bondage, unlawful confinement, and threats against their family or other persons close to them as well as other forms of physical, sexual and psychological violence

In the UK, IOM is developing a comprehensive approach to the prevention of human trafficking for forced labour and/or sexual exploitation through awareness-raising and the protection of victims through direct assistance.

As part of initial efforts by IOM UK and the Metropolitan Police to combat the trafficking of human beings, this Counter-Trafficking Directory has been produced as a tool for all those who encounter victims of trafficking to refer to, so that victims can receive the relevant services needed. We believe that through multi-agency cooperation and the sharing of information, we can provide victims of trafficking with a victim-centred response.

The purpose of this directory is to contribute alongside national efforts, and to offer service providers in the UK with a coordinated approach to ensure that they are able to provide as much protection and assistance to victims as possible. Within this resource, one will find contacts for the various types of service providers as well as for organisations whose counter-trafficking activities relate to research and advocacy work.

This resource will ensure that any agency or authority that comes across a victim of trafficking is able to provide a well coordinated response by referring to a directory that lists all CT service providers. The numerous types of services that victims of trafficking may require are as follows;

- NGO's/ INGO's
- Shelter and Accommodation
- Legal services
- Law enforcement authorities
- Health Services

By producing this resource as a 'live' document, we can ensure that this directory is continually updated. We will also develop a web portal in the near future, where this information will be found along with other CT related links and resources.

This tool is designed to maximise cooperation among those involved in the fight against human trafficking here in the UK. National Referral Mechanism

The National Referral Mechanism (NRM) is a framework for identifying victims of human trafficking and ensuring they receive the appropriate care. Authorised agencies, such as the Police, UKBA, Social Services and certain NGOs, who encounter a potential victim of human trafficking, can refer them to the Competent Authority (CA). The initial referrer is known as the 'First Responder'.

In the UK, the CAs are UKHTC and the UKBA. The UKHTC deals with referrals from the Police, Local Authorities and Non Governmental Organisations (NGOs). The UKBA deals with referrals identified as part of the immigration process.

Voluntary Victim Referral

Adults give their permission to be referred to the Competent Authority by signing a referral form. This is voluntary. If the individual does not wish to be referred, the First Responder does not contact the CA.

The Reasonable Grounds (RG) Decision

The referrals are sent to a central contact point using a standard referral form. The case is then allocated to the relevant CA for an initial decision based on whether there are reasonable grounds to believe the individual is a potential victim of human trafficking.

The Reasonable Grounds decision is based on the information supplied on the referral form. The CA aims to make this decision within 5 working days of receiving the referral.

If the decision is positive then the potential victim will be

- allocated a place within Ministry of Justice 'safe house' accommodation, if required
- granted a recovery and reflection period of 45 days

This allows the victim to begin to recover from their ordeal and to reflect on what they want to do next, for example, co-operate with police enquiries, return home etc.

The referred person and the First Responder are both notified of the decision by letter.


The Conclusive Grounds (CG) Decision

During the 45 day recovery and reflection period the CA gathers further information relating to the referral from the First Responder and multi-agency colleagues.

This additional information is used to make a full and conclusive decision on whether the referred person is a victim of human trafficking. The CA aims to make the CG decision within the 45 recovery and reflection period.

The referred person and the First Responder are both notified of the decision by letter.

AFRUCA – Africans Unite Against Child Abuse was established in May 2001 to promote the rights and welfare of African children in the UK. We also work in partnership with other organizations in Africa and across Europe.

With offices in London and Manchester, AFRUCA works with UK practitioners working with children in the African community to raise awareness and educate people on issues affecting the welfare of children so we can all act to protect them from abuse and harm. AFRUCA is also the main charity in the UK campaigning against the trafficking of African children into the country. We work closely with others to sensitise the African community- both in the UK, other countries in Europe, and in Africa – to the issues, provide support for child victims of trafficking and influence relevant governments’ policies and regulatory action.

Guided by the four “P’s” as laid down by the convention of the Rights of the Child: protection of children, prevention of violence, prosecution of criminals and participation of children in our programmes, we offer the following services as part of our anti-trafficking programme:

- **Protection and Provision of Assistance to child victims of trafficking.** This is a referral service aimed at helping trafficked children and young people access specialist legal advice, health, education and social care services.
- **Child Participation through our Survivors Forum.** A peer support group for victims to enable young people to provide each other with mutual support and assistance.

- **Prosecution:** we work closely with the Metropolitan Police Service and the Serious Organized Crime Agency in the investigation of cases, often acting as expert witnesses in immigration and criminal cases.
- AFRUCA sits on various advisory boards such as the United Kingdom Human Trafficking Centre Prevention Group, the Human Trafficking NGO Stakeholders Group chaired by Home Office Ministers, the Child Trafficking Advisory Information Line, and the Association of Chief Police Officers Child Trafficking Working Group.
- **Prevention:** Community empowerment to enable response to the crime and better safeguards for African children/victims. We run educational and sensitisation programmes to help improve knowledge and understanding of the issues and how to help protect victims.
- 1 Million Africans Against Human Trafficking Campaign on FACEBOOK: the campaign has been launched by AFRUCA to raise awareness of the scourge of human trafficking and to encourage Africans to take a stand so that there will be no place for traffickers to operate and hide.
- Skills development for practitioners through training and seminars to help develop their knowledge and understanding of key issues so they can better safeguard victims.
- AFRUCA in Nigeria: the best long term solution to end human trafficking is to tackle the “supply” problem at its source. AFRUCA’s newly established brand in Nigeria will work on the ground to help combat some of the factors that lead to children being trafficked.

This is a specialist project for sex workers & as the specialist ISVA for sex workers, I have dealt with several cases of trafficking. This is partly down to there being no specific services in the city to address the needs of this vulnerable group in terms of sexual violence and because partner agencies know I have expertise and good contacts in this area.

Due to this gap, our agency, the UK Network of Sex Work Projects and the Salvation Army (who have been faced with trafficked victims decided we needed to try and get a clear pathway in force and to develop an action plan. We have had one meeting already and are due to meet again in early 2011 We have invited the police officer in charge of the Rape Support Unit to the meeting and he is keen to progress this.

I have met with a representative from the UKBA (UK Border Agency) and along with Merseyside Police's tactical officer for prostitution we will be meeting to discuss the issue further

- Barnardo's provides three specialist services to support children and young people who have been trafficked into the UK. These are located in London, Hampshire and Manchester. The services offer direct support based on a key worker model to trafficked children and young people up to the age of 19 and in certain circumstances to the age 24. This includes:
 - Trafficking risk assessment and safety planning
 - Intensive 1 to 1 support
 - Informal advocacy and brokerage to enable access to other key services
 - Liaison with ports authorities with respect to individual cases.

- The services also provide training / awareness raising to the range of providers coming into contact with this group including police, health, social care, youth offending services, foster carers and other accommodation providers
- Information and consultancy to Local authorities in developing local policy and protocols.
- Advice, information and consultancy to the range of professionals encountering child trafficking.

BAWSO is an 'All Wales' organisation which was set in 1995 to support Black and Minority Ethnic women and children made homeless through a threat of domestic violence or fleeing domestic violence. Its work extends to providing support to black and minority ethnic women who are confronted with forced marriage, threatened honour killing, female genital mutilation, prostitution and trafficking. Annually BAWSO supports more than 700 women and 600 children.

In October 2009, BAWSO launched the first trafficking project in Wales namely 'Diogel' in partnership with the POPPY. The Diogel project provides safe house accommodation for 5 women who have been trafficked to the UK for sexual exploitation. The project also provides Outreach services to women who are unable to access temporary accommodation.

CARE works with partners abroad in countries of origin, helping local communities raise awareness of the dangers of trafficking in their area. In the UK, CARE works in partnership with Beyond the Streets, a network of over 50 grassroots projects addressing the needs of those in commercial sexual exploitation. We also work with survivors of trafficking and prostitution in the UK to advocate on their behalf. CARE advocates on the issues of tackling the root causes of exploitation (such as demand), providing better protection for those who are abused and securing effective prosecution of those who traffic and exploit others. Core Assets is the parent company of Foster Care Associates (FCA) and Fostering People (FP) which are based in the United Kingdom. FCA was founded in 1994 to provide foster placements for “Difficult to place children” and has looked after over 7,000 children.

Our thinking has been developed to support the UK with the Protection, Prevention, Prosecution and Partnership responses relating to Trafficking issues.

Across the UK, Core Assets have provided staff and carers with Child Trafficking workshops in support of potential and existing fostering placements. We have developed and updated the workshops to include advice on the National Referral Mechanism; UK's response to Child Trafficking and provided specific advice relating to the care and protection of vulnerable Young People. As a result, our carers and staff have developed an awareness of different types of exploitation, potential indicators, international factors relating to Trafficking and importantly internal Trafficking.

We have also provided support to Graduate Social Workers to ensure that they have been informed of updated practice and expectations and we plan to continue working with an established University to develop Child Protection Training with a view to incorporating Child Trafficking awareness. The International Organization for Migration (IOM) has been working to counter the trafficking in persons since 1994. In this time, the Organization has implemented almost 500 projects in 85 countries, and has provided assistance to approximately 15,000 trafficked persons. IOM's primary aims are to prevent trafficking in persons, and to protect victims of the trade while offering them options of safe and sustainable reintegration and/or return to their home countries.

IOM conducts both quantitative and qualitative research of human trafficking to better inform its own work and the work of others. Specific areas of focus have included human trafficking routes and trends, the causes and consequences of human trafficking both for the individual trafficked person and for society at large, as well as the structures, motivations, and modus operandi of organized criminal groups. While much of this work has been done at national level, IOM increasingly collects and analyzes data on human trafficking from the regional perspective to better support cooperation between states in combating the cross border trade. The Organization has also done considerable research in the areas of legislation and policy.

Direct Assistance

IOM offers direct assistance to victims of trafficking in collaboration with its partners. This includes accommodation in places of safety, medical and psychosocial support, skills development and vocational training, reintegration assistance, and the options of voluntary, safe and dignified return to countries of origin, or resettlement to third countries in extreme cases. IOM estimates that as many as one third of trafficked persons are minors, and adheres to a policy of offering specialized protection to this most vulnerable group. All IOM counter-trafficking activities are developed and implemented within a framework centred on the well being of the trafficked person.

No Recourse to Public Funds (NRPF)

A person who has No Recourse to Public Funds (NRPF) is to be defined as:

- A person subject to immigration control.
- Someone who has no entitlement to welfare benefits, public housing or Home Office asylum support and does not have the right to work.

Who would come under the NRPF category?

- People who have been refused asylum.
- Asylum seekers.
- Visa overstayers.
- People on spousal visas.
- People on student visas.
- A8 and A2 migrants who fall outside the EEA states.

Who is eligible for support?

To be eligible for care services from Liverpool City Council, including accommodation and financial support, an individual with NRPF must be:

- An adult, including adults with responsibility for children.
- Ordinarily resident in the local authority area.
- Destitute/
- Assessed as having community care or mental health needs under the National Assistance Act 1948, or be someone from whom there is a duty to support under the Children Act 1989.
- Eligible for support under immigration law (have an ongoing claim in with the Home Office).
- Someone who has to be supported to prevent a breach of their human rights, under the European Convention on Human Rights.

In addition, special concern should be given to people:

- With children and families.
- With physical health issues.
- With mental health issues.
- With domestic violence issues.
- In receipt of leaving care provisions.

Who is not eligible?

There are four categories of people who are excluded from support by immigration law. Section 54 of the Nationality, Immigration and Asylum Act 2002 placed a duty on local authorities to withhold or withdraw support from the following people.

- Nationals of the European Economic Area (other than the UK).
- People with refugee status from an EEA state.
- People unlawfully present in the UK (including those whose visas have expired).
- Failed asylum seekers who have refused to cooperate with removal directions who has exhausted all there claims in with the Home Office and should have signed up to voluntary return home.

The exception to this – the term “destitute plus”- is sometimes used as having a need for care and attention that does not solely arise from destitution. This can be applicable where withholding or withdrawing care support would result in a breach of an individual’s rights (Schedule 3 of the Nationality, Immigration and Asylum.)

Liverpool City Council has specialist workers whose role is to provide advice and information services to the person by:

- Explaining their situation and possible options.
- Giving access to practical and emotional support from a qualified worker.
- Assisting in obtaining Section 4 support from the Immigration and Nationality Directorate (IND) or from other sources of financial help. NB: Section 4 or “hard cases” support is available from NASS for refused asylum seekers who meet strict criteria.
- Referring and signposting to agencies that assist with voluntary return to country of origin.
- Helping with and advising on health care.
- Assisting with accessing other services, such as local schools and English for Speakers of Other Languages (ESOL) classes.

- Providing information about local community organisations.

Care Services

The specialist worker coordinates needs assessments and the provision of care services, by:

- Conducting immigration checks.
- Assessing individuals for community care and mental health services.
- Carrying out welfare benefit checks.
- Deciding on NRPF eligibility.
- Providing accommodation and financial or subsistence support.
- Overseeing budget control on NRPF services.
- Regularly reviewing cases.
- Monitoring council expenditure on NRPF

NSPCC CTAIL, funded by the Home Office and Comic Relief, is staffed by qualified social workers and a police liaison officer. The service offers case consultancy to professionals, giving safeguarding guidance about children and young people who are suspected to have been trafficked across international borders. If an agency brings a child or young person to their attention, they will advise professionals on the child or young person's situation in collaboration with other agencies.

CTAIL also delivers awareness-raising presentations and workshops to professionals from a wide range of agencies, and has provided training for UKBA asylum case-owners and NRM Competent Authorities within the UK Human Trafficking Centre (UKHTC) and the UK Borders Agency (UKBA). They also gather information and data to gain a wider understanding of the causes of and issues around trafficking, which informs national statistics and reports for the Home Office.

The service runs two participation groups, comprised of young men and young women who were trafficked to the UK and who now offer the team insight into the issue of child trafficking, providing advice, recommendations and direction to the service, based on both their knowledge and experience.

The service welcomes calls from any professional who has concerns about an individual child, and is also happy to talk through any wider concerns relating to child trafficking. The team will endeavour to respond to requests for information and to work collaboratively with other agencies to help safeguard children who may have been trafficked and to prevent new cases of child trafficking.

STOP THE TRAFFIK is a global movement of individuals, communities, and organisations fighting human trafficking. We have made a life-changing impact around the world:

In 2006 we launched **Business Travellers against Human Trafficking**, informing and equipping them to identify and report suspected cases worldwide. After one report, we were able to help a trafficked woman that a businessman had encountered in a hotel in Dubai. This has now prompted a campaign in Belgium to stop staff in international hotel chains profiting from human trafficking.

In 2007 we launched the **Chocolate Campaign** to campaign against child trafficking in the cocoa industry. By 2009, Verkade and Swiss Noir in the Netherlands, and Cadbury's, Mars, and Nestle in the UK had committed to using fairly traded and traffic-free cocoa in some of their products.

In 2008 we launched **Active Communities against Trafficking (ACT)** with various police forces, equipping people to raise awareness of and map indicators of human trafficking in their areas. As a result of this work, victims have been rescued from human trafficking across the UK.

In 2009 we launched the **Start Freedom** campaign with the UN to educate young people about human trafficking. By 2010 3,300 people from 97 countries had registered online for resources in 10 languages. We also hosted the world's first Global Classroom on human trafficking which saw 180 young people across 5 continents learn more about what they can do in their communities.

In 2010 we launched the **Freedom Ticket For Life** campaign alongside four major charities, raising awareness and funds to prevent vulnerable women and girls being trafficked. Sponsored runs are now being organised worldwide. We are also launching **Finance Against Trafficking**, informing and equipping the private sector to play their part in tackling human trafficking.

In 2011 we will launch our **Olympics** campaign to prevent human trafficking before, during, and after the 2012 London games.

STOP UK is a small charity with a large remit. We are driven by our mission statement of “Prevention before Tragedy” and are committed to raising awareness of Human Trafficking with the provision of practical support to the victims of this shameful crime.

Receiving charitable status in 2006, a number of initiatives for victims were introduced. These include the provision of rescue and shelter, physical and physiological medical aid, legal assistance, the renewing of legal and travel documents, family tracing and victim witness co-ordination.

- STOP UK Helpline receives 25 – 30 calls for assistance each week. Information received from calls has resulted in several successful police operations. The Poppy Project is the UK's leading service provider for victims of trafficking, providing support and housing to women trafficked into the UK for sexual exploitation or domestic servitude. Since March 2003 The Poppy Project has been funded by the Ministry of Justice and can provide accommodation and support to 54 women at any one time. The Poppy Project houses women in safe, women-only properties in London (40 bed spaces), Cardiff (five bed spaces) and Sheffield (nine bed spaces) and provides intensive support addressing women's practical, emotional and psychological needs.

The Poppy Project comprises acute and outreach services. The acute service provides long-term support, including accommodation within the project, for victims of trafficking with high needs. The outreach team conducts assessments and provides short-term crisis intervention, support and advocacy for victims of trafficking who do not require accommodation. Women accepted onto the project are allocated a Senior Support Worker with whom they meet on a regular basis. Senior Support Workers provide ongoing practical and emotional support, as well as advocacy to enable women to access a wide range of services, including health services, counselling and access to legal advice.

Access to the project is dependent on women meeting certain criteria set by the Home Office: that she is over 18 years of age; that she has been trafficked into the UK; that she has been exploited in prostitution or domestic servitude in the UK; and that women accessing the acute service

are willing to consent to enter the National Referral Mechanism (NRM). In accordance with the Council of Europe Convention on Action against Trafficking (ECAT), women accessing Poppy Project services are not required to cooperate with the police as a condition of receiving support and accommodation, but are supported to do so if and when they choose.

International coach travel has been identified as a cheap and unchecked entry/exit route into London & the UK and as such must be taken into consideration as part of any joined-up counter trafficking strategy.

Cathy Zimmerman is a founding staff member of the Gender Violence & Health Centre at LSHTM. She is a behavioural scientist lecturing on violence against women, migration and public health policy. She has conducted multi-country research on the health of trafficked women and adolescents, which generated the first-ever data on the health risks and outcomes associated with trafficking (www.lshtm.ac.uk/genderviolence).
